RULES AND DAILY ROUTINE

Since you are now a student of International European University, please read below the following rules obligatory for all our students:

Classes:

Attendance of lectures by students are under strict control both by professors of the University and Migration Service authority of Malta. Thus, any unreasonable missing of lectures can be a reason for immediate visa cancellation.

- Missing class could be a cause of such serious reason as visiting a doctor at any official authorities. Students should provide the Dean's office with the official document from the doctor about his/her illness or the official request from the official authority just on the first day after they came back to classes.

Being late for class by more than 15 minutes is considering as missing class.

All missed classes must be made up according to the schedule agreed with the teacher.

Leisure:

- Students must be aware of their behavior outside the University, including their personal lives. If the behavior of student violates the rules or laws of the country, official actions may be taken against him/her, including expulsion from IEU.

Accommodation:

- Students are living in apartments provided by the University. Usual accommodation for two people per room apartments all fully furnished with a range of amenities, including shared kitchen and common restroom facilities.
- Students can change their place of living in accordance with their requirements for convenience at their own expense.
- Students should keep their apartments in proper order. All cleaning and washing processes inside the apartment should be made by people living in this apartment. In case of any breakdowns, they should be reported to the responsible person.
- Rules of garbage utilization is very strict in Malta, so please control the schedule of different types of garbage utilization and follow it. Failure to strictly adhere to recycling rules will result in penalties from the local administration.

The schedule will be as follows:

Monday: Organic waste (white bag)

Tuesday: Mixed waste (black bag)

Wednesday: Organic waste only (white bag)

Thursday: Recycled waste (Grey or green bag)

Friday: Organic waste (white bag)

Saturday: Mixed waste (black bag)

The collection of glass bottles will be carried out on every first and third Friday of the month.



Between April and October 2023, the authorities are conducting an educational campaign to familiarise the public with the new mandatory waste separation regulations.

During this period, persons (even those operating within the context of a commercial activity) caught disposing of waste inappropriately will receive a warning. After the lapse of these six months, as of October 14, 2023, businesses caught disposing of waste inadequately will be fined €75, while households will be fined €25. These fines will double to €150 and €50 respectively if the individual is caught repeatedly disposing of waste inappropriately.

GUESTS

Guests: In order to ensure enough space and the best service for everyone, there are some rules for bringing guests to IEU Student Housing. Guests cannot stay overnight, as it's important for us to ensure the comfort of all residents in the student housing. It's important to respect the comfort zones of other members. If any member of the student housing has a guest stay overnight, a fine will be imposed.

If a serious incident occurs and is captured on security camera footage, the recording will be provided to authorized officials who will take appropriate disciplinary action. Violations of the code of conduct, including serious misconduct, will result in contract termination and may lead to further disciplinary action by the University.

Dean's Office

The Dean's Office is a key administrative unit of the university that supports you throughout your studies:

1. Academic process consultations – assistance in selecting courses, creating individual study plans, and scheduling.
2. Document processing – issuing certificates, confirmations of enrollment, academic transcripts, and student ID cards.
3. Academic performance issues – providing information on current grades, assistance with retaking exams or assessments, withdrawal or reinstatement.
4. Study leave – assistance in arranging academic or medical leave.

5. Communication with faculty – support in connecting with professors and resolving academic concerns.
6. General inquiries – informational support on any organizational matters related to your studies.

The Dean's Office is your main assistant in addressing academic and organizational issues.

Group Curators

University staff members who help students feel more confident and organized. They play a key role in fostering a positive learning environment and supporting each student on their path to success.

How curators can assist:

1. **Academic Support** – A curator helps students navigate the learning process, set priorities in their studies, and can offer advice on how to effectively manage their time.
2. **Adaptation to Student Life** – New students often find it difficult to adapt to new conditions. Curators help them understand the university structure, behavior rules, and provide general support with organizational matters.
3. **Conflict Resolution** – In case of misunderstandings or issues, whether with professors or classmates, a curator can act as a mediator or help find a solution.
4. **Psychological Support** – Curators pay close attention to students' emotional well-being, can offer advice, or refer them to specialists if necessary.
5. **Event Organization** – Curators are often involved in organizing cultural and social events, such as meetings, excursions, or student activities, which help bring the group together and create a friendly atmosphere.

EUROPEAN MEDICAL SCHOOL

European Medical School is an educational and research institute of the International European University, where a completely new approach to the learning process has been introduced. The basis for the educational programs of our Medical School are European curricula.

MISSION

The mission of EMS is a valuable contribution to social development by training qualified, competent and competitive graduates able to organize and conduct professional activities at a high level, critically analyze healthcare issues and solve complicated tasks on their own in the public health sector.

VISION

The vision of EMS is to gain leadership positions in the global medical space in the high-quality pre-graduate medical training by introducing efficient programs providing the high level of theoretical and practical skills; to develop individual clinical thinking; to integrate into the European global community; to be able to analyze a situation and scientifically substantiate decision-making approaches.

Control measures include:

- initial control;
- current control;
- final control;
- student examination in the form the Unified State Qualification Exam.

The **initial control** implies determining the initial level of students' knowledge acquired in related disciplines required for mastering the discipline. The results of the initial control are not taken into account in the current training, as they are only informative for the lecturer.

The **current control** implies 100% questioning of students of the academic group and is carried out during classroom activities of all types (practical, laboratory, seminar) with mandatory assessment of all components of the class: test control, oral questioning, solving situational problems, description of drugs, etc. The main task of the current control is to check the level of preparation of students for performing a specific job, to provide feedback between the lecturer and students in the learning process, to ensure the management of students' learning motivation.

The **final control** is carried out to assess the results of learning at a certain educational level or at its individual completed stages according to the national scale and the ECTS scale. The final control includes:

- semester control;
- Krok Licensing Integrated Exam;
- state examination of students.

Semester control in the discipline is an obligatory form of assessment of students' learning outcomes. It is carried out in accordance with the curriculum in the form of a Pass/Fail test, graded test or exam within the deadlines stipulated by the schedule of the educational process and in the amount of educational material determined by the discipline program.

Semester Pass/Fail test is a form of final control, consisting in assessing the mastery of educational material by the student solely on the basis of the results of his/her performance of certain types of work during practical, seminar or laboratory classes.

Semester graded test is a form of final control, consisting in assessing the student's mastery of educational material in a particular discipline based on the current control and completed individual tasks at the last class.

Semester exam is a form of final control of the student's mastery of theoretical and practical material in a particular discipline. The form of exam final control is provided for disciplines that are part of Krok integrated test exams and state examination.

The form of the exam should be standardized and include control of theoretical and practical training.

USQE Stage 1 and Stage 2 Licensing Integrated Exams are one of the forms of final independent quality control of students' training conducted by the Testing Board at the Ministry of Health of Ukraine. **Objective Structured Clinical Examination (OSCE)** is an assessment designed to evaluate a graduate's readiness to perform professional activities by demonstrating practical components of professional competence in conditions as close to real-life practice as possible.

OSCE assesses a graduate's ability to perform work-related tasks on a real object of professional activity (a person) or on a model of such an object (phantom, mannequin, situational task, etc.), which cannot be adequately evaluated through standardized testing methods.

The purpose of OSCE is to evaluate the quality of how graduates solve typical and situational professional tasks and demonstrate relevant skills and competencies in conditions that closely resemble actual professional practice.

Graduates undergo a comprehensive OSCE covering four disciplines: "Internal and Infectious Diseases," "Obstetrics and Gynecology," "Pediatrics and Pediatric Infectious Diseases," and "Surgical Diseases." Results are recorded separately for each of the four disciplines. The OSCE is conducted in specially equipped rooms called "**OSCE Stations**" and evaluates communication, cognitive, basic (physical examination techniques), and advanced (physical examination aimed at identifying and interpreting symptoms and syndromes) practical skills and procedures.

It also assesses the graduate's ability to gather complaints, conduct objective examinations, plan diagnostics, interpret laboratory and instrumental study results, establish and justify preliminary clinical diagnoses, and determine treatment strategies.

Examination is regulated by the Regulations on the Examination of Students and the Work of Examination Committees at International European University

RECTOR'S CONTROL

Conducted in accordance with the order of the Rector of IEU, this measure represents an external level of control designed to evaluate the quality of the educational process and compare the effectiveness of student learning.

Rector's control assesses the stability of residual knowledge, skills, and competencies, and is conducted on topics from the disciplines studied during the current or previous semester.

Forms of Rector's Control:

- Rector's control of the curriculum content to assess residual knowledge of students. This type of control is conducted in the form of comprehensive control tasks developed by the academic staff of the relevant department teaching the respective disciplines.
- Rector's control is conducted using developed comprehensive test assignments. Testing as part of the rector's control is carried out according to the Rector's order after the study of the discipline. The procedure for conducting this control is defined by the Rector's corresponding directive at IEU.

APPEALS COMMISSION

During the final semester evaluation period, an Appeals Commission is established by the order of the Director of the "European Medical School" Educational and Scientific Institute (ESI). The commission consists of the ESI Director, the Deputy Director, the Head of the Department, and the Chairperson of the Student Parliament. The commission is responsible for reviewing student appeals or complaints regarding the final semester assessment of higher education students' knowledge.

To ensure adherence to the principles of integrity, responsibility, academic freedom, and objectivity:

- The Appeals Commission reviews the appeal no later than the next day after its submission.

- The decision regarding the appeal is communicated to the student immediately after it is made, and both the student and the commission members sign the relevant protocol.

Appeals of final assessment results are an integral part of the organizational framework of the educational process, in accordance with current legislation and the requirements of the Bologna Declaration. The purpose of the appeals review process is to determine the objectivity of the assigned grade.

The primary goal of the appeal procedure is to eliminate subjectivity in the assessment of students' knowledge, avoid misunderstandings and disputes, and create favorable conditions for ensuring the legitimate rights and interests of students.

Students have the right to appeal any final grade assigned under the ECTS grading scale (from "F" to "B") or the national scale (from "unsatisfactory" to "very good") in any discipline.

ASSESSMENT OF STUDENTS' LEARNING OUTCOMES

The ECTS grade for the discipline is determined as the sum of grades:

- for current learning activities – up to 120 points;
- for the final control (graded test, exam) – 80 points.

The maximum amount of scores for the discipline is 200 points. Correlation between the results of current learning activities and final knowledge control: **60% and 40%**

From 4 to 12 points are additionally allocated for the assessment of students' independent work out of 120 points allocated for current learning activities according to the working program. Bonus points are added either to the current grade or to the final grade in the discipline at the end of its learning.

To carry out control activities, the University applies the following assessment scales:

- ✓ 200-point scale;
- ✓ traditional 4-point scale;
- ✓ ECTS rating scale.

The results are converted from one scale into another according to tables

ASSESSMENT OF CURRENT LEARNING OUTCOMES

The current control is obligatory. In assessing learning of each topic of all curriculum disciplines during current training activities, students receive grades due to the 4-point scale (traditional scale) taking into account approved assessment criteria for the discipline. All types of works prescribed by the program are considered. Students should obtain a grade in each topic.

The final grade for current learning outcomes is recognized as the arithmetic mean of the grade for each class.

Traditional grades are converted into points according to the scale for converting traditional grades into rating points.

ASSESSMENT OF LEARNING OUTCOMES IN DISCIPLINES, THE FORM OF FINAL CONTROL OF WHICH IS AN EXAM OR A GRADED TEST

The final control in the form of an exam or graded test is carried out after learning all the topics of the discipline, during the examination session.

The final control is carried out in any form (written work, testing, etc.). The form of the final control is agreed at the meeting of the department. The form of the final control should be standardized and include the control of practical and theoretical training.

The grade for the discipline is determined as the sum of final points for current learning activities and points for the final control and is expressed in the multi-point scale.

— The maximum amount of points that can be obtained by students for current learning activities during the semester to be admitted to the final control is 120.

— The minimum amount of points that should be obtained by students for current learning activities during the semester to be admitted to the final control is 72.

— The calculation of the amount of points is based on grades obtained by students according to the traditional scale while studying the discipline by calculating the arithmetic average. The obtained value is converted into points in the multi-point scale in accordance with Table 4:

The maximum amount of points that can be obtained by students during the final control is 80.

— The final control is considered passed if students obtain at least 60% of the maximum sum of points.

— The minimum amount of points that should be obtained by students during the final control is 48.

The grade for the discipline completing with the exam is determined as the sum of points for current learning activities (at least 72), points for individual independent work of students (no more than 12) and points for the exam (at least 48) (Table 5). The total points for the discipline should not exceed 200.

Students who perform all types of scheduled educational work within the training period, make up all missed classes and receive at least 72 points due to the results of current performance are admitted to the final control.

The grade for the final control is given according to the traditional 4-point scale and converted into the 200-point scale

The grade for the discipline completing with the final control is determined as the sum of points for current learning activities (at least 72), including points for

individual independent work of students (no more than 12) and points for accomplishing the final control at the last class (at least 48). Repeated final semester control in order to improve a positive grade is not provided.

If students obtain the fail grade for the final control, they should retake it. In this case, the maximum grade that can be obtained for the final control is 3.

ASSESSMENT OF LEARNING OUTCOMES

Assessment of learning outcomes includes intermediate, current and final control measures.

The main types of control measures are current control, final control and semester control.

The system of assessment of students' knowledge in each discipline includes current and final semester control of knowledge, assessment of practical training outcomes and execution of term papers at a certain level of higher education.

CURRENT AND FINAL SEMESTER CONTROL

The current control is carried out within the semester during lectures, practical classes, current examination and during the examination week before the test and examination session and is assessed by the amount of points.

During the current control, one assesses the level of theoretical knowledge and practical skills on the topics included in the discipline, the level of knowledge demonstrated in answers and speeches; activity in discussing issues during practical classes; results of completion and defense of term and control papers, independent study of topics; performing tests, making calculations, writing abstracts (essays); processing workbook tasks, preparing individual assignments The results of the current control are recorded in the Lecturer's Log of Academic Groups.

Current assessment of students' knowledge can be conducted in the following forms:

- oral questioning of students during practical classes and assessment of their knowledge level;
- check of correctness of solved practical problems;
- rapid survey (oral or written).

The results of current control of student knowledge are assessed in general (due to all forms of works) ranging from **0** to **60** points.

Students are admitted to the final control if they fulfil the requirements of the training program and obtain at least **36** points

Students who miss the current control for valid documented reasons have the right to take the current control **within two weeks** after returning to studying.

Students who miss classes **without valid reasons**, do not participate in current control activities and do not liquidate academic failure are not admitted to the final semester control of this discipline. In this case, an academic staff member puts a mark '*non-admission*' into the examination (credit) record on the day of the exam (Pass/Fail test).

Re-taking of the exam (Pass/Fail test) in the discipline is appointed in case of accomplishing all types of educational, independent (individual) work stipulated by the working program of the academic discipline and is carried out according to the approved schedule of academic failure liquidation.

The final semester control of a certain discipline is an obligatory form of student performance control. It is carried out according to the curriculum in the form of **exam** or **Pass/Fail test** in the period stipulated by the schedule of the educational process and in the amount of training material defined by the working training program of the discipline.

The total grade for the discipline is calculated as the sum of scores for current assessment activities, individual task (if it is provided by the working program) and points obtained during the final semester control.

The overall sum of points is **100**. The total grade for the discipline is given according to the national and European scale.

RECTOR'S CONTROL

Rector's control is a control of the stability of residual knowledge, skills and abilities and is carried out on the topics of disciplines studied in the current or previous semester.

Forms of Rector's control:

- Rector's control over the educational program of the educational component to check the residual knowledge of students. Such Rector's control is carried out in the form of comprehensive test works developed by the academic staff of the Department who teach corresponding disciplines;
- Rector's control is carried out based on developed comprehensive test works. The Rector's control in the form of testing is carried out in accordance with the Rector's order after studying the discipline. The procedure is determined by the relevant order of the IEU Rector.

APPEAL OF THE RESULTS OF THE FINAL SEMESTER CONTROL

The list of exams and Pass/Fail tests of semester control is stipulated by the working curriculum.

The number of exams in each session should not exceed 5, and Pass/Fail tests - 6, while taking into account that the number of academic disciplines (compulsory and elective) should not exceed 16 per year and, accordingly, 8 per semester (excluding Pass/Fail tests in practical training and defense of term papers).

Students are considered to be admitted to semester control in a particular discipline (semester exam, Pass/Fail test) if they have completed all the types of work stipulated in the semester curriculum for that discipline.

For the period of the final semester control, the Appeal Committee consisting of the Director of EBS, the Deputy Director, the Head of the Department and the Chair of the Student Parliament is established by order of the Director of EBS to consider appeals (complaints) of students regarding the final semester control of students' knowledge.

In order to comply with the principles of integrity, responsibility, academic freedom and objectivity:

- the Appeal Committee considers the student's appeal (complaint) no later than the next day after submission;
- the results of consideration of the appeal (complaint) are reported to the student immediately after the decision is made, and the student and members of the Committee sign the relevant protocol.

Appeal of the results of the final control of students' knowledge is a component of the organizational support of the educational process in accordance with current legislation and taking into account the requirements of the Bologna Declaration. Consideration of the appeal is carried out to determine the objectivity of the grade.

The main objective of the appeal procedure is to overcome elements of subjectivity in assessing students' knowledge, avoid misunderstandings and disputes, and create the most favorable conditions for the development and real assurance of the legitimate rights and interests of students.

Students have the right to appeal against any final grade received on the ECTS scale (from F to B) or on the national scale (from Fail to Very Good) assigned to the discipline.

Assessments of knowledge revealed during the final examination – defense of the final qualifying paper are not subject to appeal. In this case, all disputes are resolved by the Examination Committee.

Based on the results of the appeal, the Committee makes one of two decisions:

- ***The grade assigned in the discipline (name of the discipline) corresponds to the level and quality of the work performed and does not change.***
- ***The grade assigned in the discipline (name of the discipline) does not correspond to the level and quality of the work performed and is increased by ... points (a new grade is specified in accordance with the accepted knowledge assessment system).***

PROTECTION OF PERSONAL DATA POLICY

All processes of data collection and processing at the International European University comply with the requirements of the Law of Ukraine "On the Protection of Personal Data" and the General Data Protection Regulation (GDPR). The University has its own policies on information management, including the Regulations on the Procedure for Processing and Protection of Personal Data and the Internal Quality Assurance Policy. To comply with the legislative acts of Ukraine, the General Data Protection Regulation (GDPR), and internal provisions, the University has implemented the following measures:

The University will never notify the police on its own without your consent, unless the safety of you or others is endangered by not reporting the incident.

BULLYING COUNTERACTION POLICY

To prevent bullying in the team of the International European University, events were planned and held to provide regulatory and informational support for the prevention of bullying at the university.

We monitored the information availability of rules of conduct and regulations on bullying prevention, and conducted an anonymous survey of higher education students about cases of bullying at the University. Prevention and diagnostics of interpersonal relationships among students, academic staff and other University personnel were carried out.

Work was carried out with applicants for higher education and with research and teaching staff. It was conducted in the format of anti-bullying trainings and consultations on the protection of personal rights.

Students who have become aware of cases of bullying (harassment) are obliged to report in writing to the management of the University about the facts of bullying (harassment) against students, pedagogical, scientific and pedagogical, research workers, and other persons involved in the educational process, which they personally witnessed or about which they received reliable information from other persons.

Consideration and clarification of the circumstances of cases of bullying (harassment) is carried out in accordance with the complaints filed. The responsible person receives and registers the submitted complaints. The complaint form is published on the official website of the institution. You can file a complaint through a form or a trust box, which can be found on the official website of the institution. After the official submission of the complaint, the complainant is assigned a responsible person to verify the facts stated in the complaint.

If the facts set forth in the complaint are confirmed, the university management takes measures aimed at stopping and stopping bullying (harassment) in the institution.

ASSESSMENT OF STUDENTS' ACHIEVEMENTS POLICY

Assessment of students' achievements is an important part of the educational process. It helps to determine the level of mastery of the material, readiness for further learning and development. Assessment of students' knowledge, skills, and abilities allows teachers to plan and improve the learning process, as well as identify gaps and help eliminate them.

The role of assessment is to support students in achieving program learning outcomes through effective feedback. And the development of self-assessment capabilities to ensure effective further learning of students. The student also has the right to appeal any final grade received.

The purpose of considering an appeal is to determine the objectivity of the grade, as well as to create conditions for the development and provision of real protection. And to overcome the elements of subjectivity in assessing student achievement.
